GJX - Rules and Regulations – Guest

1. Rules and Regulations

In registering for or accepting the offer of admittance to the Exhibition, visitors agree that they shall observe and comply with these rules and regulations and with the rules and regulations of the **GJX** Exhibition.

2. Conduct in the Exhibition Center

Visitors shall not do, or permit anything to be done, which shall cause a disturbance, nuisance, annoyance, inconvenience, damage or danger to any person or thing or which in the opinion of **GJX** does not conform to the general standards of the Exhibition or amounts to a breach of these rules and regulations or applicable laws and regulations generally applying.

Visitors may not bring any camera, video recorder or recording equipment of any kind to the Exhibition without the prior written consent of **GJX**. **GJX** reserves the right to search the belongings of any visitor at any time.

It is expressly prohibited for visitors to record images in any form while attending the exhibition without the prior written consent of **GJX**. Such prohibition includes, but is not limited to, the taking of photographs, video recording of any type and drawing or sketching of images. Visitors agree to surrender to **GJX** on demand any material in whatever media on which images may be recorded in violation of this rule, including but not limited to film, video tapes, sketchbooks, camera phones and digital storage devices.

GJX reserves the right to refuse admittance to any visitor or to require any visitor to leave if in GJX's opinion his or her behavior is in breach of these rules and regulations generally applying. The opinion of GJX is final in this regard.

Official **GJX** Show badges must be worn and plainly visible at all times by all individuals on the exhibit floor.

A badge may be worn only by the person whose name appears on it. Anyone wearing or supplying an unauthorized badge or a badge belonging to another person will be subject to immediate removal from the show.

"Hawking", promoting or showing of merchandise in the exhibition area is strictly prohibited.

3. Liability

GJX shall not be liable to any visitor for any loss of or damage to any of his or her property occurring (from whatever cause) in or about the Exhibition Center nor for the death of or any injury sustained by any visitor whilst on or leaving the Exhibition Center (other than from death or injury resulting from **GJX** negligence to the extent this cannot be excluded or restricted at law (and then only to such extent).

The visitor agrees that **GJX** shall not incur any liability to him or her for any products displayed or sold by any exhibitor at the Exhibition.

The visitor agrees that **GJX** shall not incur any liability to him or her for any error or omission in any information relating to any exhibitor or its products in the Exhibition's official directory or in any other promotional or other printed materials or information provided by **GJX** or the exhibitor.

No waiver by **GJX** of any of the provisions of these rules and regulations or of any of its rights hereunder shall have effect unless given in writing and signed by **GJX**.

Buyer/Guest agrees to indemnify and hold harmless **GJX**, Show Management Co., L.L.C., Nor-Generations, L.L.C., and each of their respective officers, agents and employees against all claims, losses, suits, damages, judgments, expenses, costs, including without limitation legal fees and charges of every kind arising out of or resulting from any act or failure to act by Buyer/Guest.

4. Personal Data

Visitors agree that the personal data provided for registration for the Exhibition may be included in **GJX** database and used by **GJX** or passed onto third parties for promotion purposes.

For security purpose and in order to prevent and detect crime, visitors may be subject to a random bag search and CCTV camera recording in the Exhibition Center.
